Reside (f) You will reside at _____ or any other address approved by your Supervisor;

Inside your residence (g) For the purposes of this Conditional Sentence Order, the phrase “inside your residence” shall include being in the yard of your residence.

House Arrest (h) You will for the first _____ months of this sentence
From _____ to _____,

be inside your residence subject to the following exceptions:

(1) *Medical Emergency* If you are attending a hospital or medical clinic due to a medical emergency for you or a member of your immediate family who lives with you;
And Ensure your CSO Supervisor is aware of the situation as soon as it is safe to do so

(2) *Meeting with supervisor* If you are going directly to, at, or coming directly home from a scheduled meeting with your Supervisor;

(3) *Medical or Dental Appointments* If you are attending a scheduled medical or dental or government appointment for you or a member of your immediate family who lives with you, so long as you have notified your Supervisor and obtained permission from your Supervisor;

(4) *Written approval of supervisor* If you have written approval from your Supervisor to be outside your residence and you are carrying such written approval;

(5) *Job Interview or Registration for Educational Program* If you are going directly to, at, or coming directly home from an interview or appointment relating to gaining employment or enrolling in any program recommended and approved by your Supervisor;

(6) *Work* If you are going directly to work, at work, or coming directly home from work with a schedule provided to and approval of your Supervisor;

(7) *School or Training program* If you are going directly to, at, or coming directly home from an educational or training program that has been approved by your Supervisor;

- (8) Counselling If you are going directly to, at, or coming directly home from any counselling recommended by your Supervisor;
- (9) Community Service Work If you are going directly to, doing, or coming directly home from a location where you are doing Community Service Work hours which has been pre-approved by your Supervisor;
- (10) Exercise Activity If you are going directly to, at, or coming directly home from an organized sporting event that you are participating in or an exercise facility where you are doing physical exercise as long as you have permission from your Supervisor beforehand of where you will be;
- (11) Spiritual or Religious Activity If you are going directly to, at, or coming directly home from an organized spiritual function, assembly, or similar event, as long as you have permission from your Supervisor beforehand of where you will be;
- (12) Personal Business Every _____ from _____ to _____ to conduct errands and to shop for the necessities of life;
- (13) Court If you are going directly to, at, or coming directly home from attending Court if you are required to do so;
- Curfew* (i) For the last _____ months of this sentence, you are to be inside your residence every day from _____ to _____ unless prior written permission has been given by your Supervisor to be out of your residence during those hours or unless you are attending a hospital or medical clinic due to a medical emergency for you or a member of your immediate family who lives with you; and ensure your CSO Supervisor is aware of the situation as soon as it is safe to do so
- Cooperate with Random Checks* (j) You will cooperate fully with random checks by telephone and in person by your Supervisor or the police to verify your compliance with this conditional sentence.
This includes the requirements that:
(1) if the police or your Supervisor come to your residence, then you will come to the door of your residence personally if you are in the residence; and
(2) if the police or your Supervisor phone your residence, then you will speak to them on the telephone if you are in the residence;
- No Contact or communication* (k) You will not have any contact or communication directly or indirectly with _____ You are not to attend at their place of residence, employment or education, or worship., unless approved by your supervisor.
- Counselling* (l) You are to actively participate in any assessments, counselling, programs or other activities (*or treatment programs*) as recommended by and to the satisfaction of your Supervisor, including but not limited to ...
