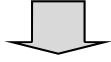


APPLICATION TO JUDGE

(Paragraphs 21(1)(a) and (2)(a))

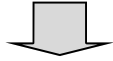
STEP 1

COMPLETE the APPLICATION TO JUDGE. To complete this form, type or print clearly.



STEP 2

FILE the APPLICATION TO JUDGE by taking or mailing it to the Territorial Court registry. You will be required to pay a fee. The staff will file the original application on the Territorial Court file. If a hearing is required, registry staff will set a date for a hearing at least 21 days from the date of the APPLICATION or as ordered by a judge.



STEP 3

The Territorial Court registry will send a copy of the filed APPLICATION TO JUDGE and, if applicable, a NOTICE OF HEARING to you and each party. Notice of the date and time of the hearing, if any, is contained in the APPLICATION TO JUDGE.

It is possible, in urgent cases, that a judge may make an order even though the other parties have not been served with the APPLICATION TO JUDGE and NOTICE OF HEARING. If that is necessary, be sure to explain that in your APPLICATION TO JUDGE so that a judge may consider your argument.
