You will cooperate fully with random checks by telephone and in person by your Supervisor or the police to verify your compliance with this conditional sentence.

This includes the requirements that

- (1) if the police or your Supervisor come to your residence, then you will come to the door of your residence personally if you are in the residence; and
- (2) if the police or your Supervisor phone your residence, then you will speak to them on the telephone if you are in the residence;

Abstain from Drugs

You will abstain absolutely from the possession or consumption of any non-prescribed illegal drugs;

You will abstain absolutely from the possession or consumption of any cannabis or cannabis product;

Abstain from Alcohol

You will abstain absolutely from the consumption of any alcoholic beverage;

No contact

You are not to be in the company of, or have contact with, any person known to use or sell illegal drugs;

Sign Releases

You will sign releases in favour of your Supervisor to enable the Supervisor to confirm attendance at employment, school, counselling or community service;

Carry copy of CSO

You will carry a copy of this conditional sentence order, as well as any written authorizations provided by your supervisor, on your person at all times you are not in your residence, and provide them on demand to a peace officer.
