Commonly-Referred-to Authorities


Attached are two lists of authorities which the Supreme Court does not require the parties to reproduce in their book of authorities. This applies to motions, trials and summary conviction appeals.


Appendix "A" is a list of authorities in family law cases (divided by subject-matter).


Appendix "B" is a list of authorities in criminal law cases (divided by subject-matter).




