NOTICE OF RELOCATION

PART 1: IMPORTANT INFORMATION FOR THE PERSON(S) RECEIVING THIS NOTICE

TO: *(insert name of the person(s) receiving this notice)*

The person giving you this Notice of Relocation is planning to move.

IF YOU HAVE PARENTING RESPONSIBILITIES: If you have an order that gives you parenting time and/or decision making responsibility (or an order made under the *Divorce Act (Canada)* before March 1, 2021 giving you custody or access) for a child named in this Notice of Relocation, you may OBJECT.

If you object to the relocation you must file a Notice of Objection to Relocation (Form 21) OR bring an application under s. 16.1(1) or s. 17(1)(b) of the *Divorce Act (Canada)* with the Supreme Court of the Northwest Territories. **YOU MAY NOT OBJECT OR APPLY TO STOP A RELOCATION THAT DOES NOT INVOLVE A CHILD.**

You must file and serve the Notice of Objection to Relocation or application on the person who gave you this notice within THIRTY (30) DAYS OF RECEIVING IT. His/her/their address is provided in this Notice of Relocation.

IF YOU DO NOT file and serve the Notice of Objection or court application **WITHIN THIRTY (30) DAYS** and there is no court order prohibiting the child(ren)'s relocation, then the relocation can go ahead without further court order on or after the date indicated in the Notice of Relocation.

IF YOU HAVE AN ORDER FOR CONTACT WITH THE CHILD(REN): If you have an order granting you contact with the child(ren) you cannot object to the child(ren)'s relocation.
